PETITION FOR NATURALIZATION

(17) I am, and have been during all of the periods required by law, attached to the principles of the Constitution of the United States and well disposed to the good order and happiness of the United States. (18) I have resided continuously in the United States of America for the term of 2 years at least immediately preceding the date of this petition, to wit: since May 16, 1950. (19) I have not heretofore made petition for naturalization.
